2.  - 3.5. For e-voting, the voting results with details of equity shareholders who have voted in favour of the Resolution or against the Resolution and those who have abstained from voting were downloaded from the website of Central Depository Services (India) Limited i.e. (<u>https://www.evotingindia.com</u>).
